## RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT

Undersigned furthermore waives for himself/herself and for his/her executors, personal representatives, administrators, assignees, heirs, and next of kin, any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he/she may have or which may arise against the club (including but not limited to the death of Undersigned and/or any and all injuries, damages or illnesses suffered by Undersigned or Undersigned's property), which may in any way whatsoever, arise out of, be related to or be connected with any activities, the Premises, including any latent defect in the Premises; Undersigned's presence on or use of said Premises; Undersigned's property and, the discharge of firearms. The club shall not be liable for, and Undersigned, on behalf of himself/herself and on the behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases the Club from any and all such claims and liabilities.

No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by the Club shall not constitute any waiver of the Club's right to pursue other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.
